To Whom This May Concern,

Thank you for allowing Paramount Exterminating Company to provide pest management services over the past year. We have endeavored to supply a service that protects the students, staff and property from pests by utilizing Integrated Pest Management strategies.

As part of the New Jersey Integrated Pest Management Act (C.13:1F-24), annual notification of pesticides used on school property must be distributed to parents, guardians and all school employees. The IPM coordinator maintains the product label and material safety data sheet, when available, of each pesticide that may be used on school property. The label and data sheet is available for review by a parent, guardian, staff member, or student attending the school. Also, the IPM coordinator is available to parents, guardians, staff members, and students to provide information for, and receive comments about, IPM activities and pesticide use. As part of a school pest management plan, **Waldwick Board of Education** may use pesticides to control pests. The United States Environmental Protection Agency (EPA) and the New Jersey Department of Environmental Protection (DEP) register pesticides to determine that the use of a pesticide in accordance with instructions printed on the label does not pose an unreasonable risk to human health and the environment. Nevertheless, the EPA and DEP cannot guarantee that registered pesticides do not pose any risk to human health, thus unnecessary exposure to pesticides should be avoided. The EPA has issued the statement that where possible, persons who are potentially sensitive, such as pregnant women, infants and children, should avoid unnecessary pesticide exposure.
