Annual Asbestos Notification

Dear Parents Teachers and all employees:

In accordance with the Asbestos Hazard Emergency Response (AHERA), all staff members must be notified annually of the district's activities regarding Asbestos Containing Materials (ACM) located within the Waldwick Board of Education.

During the past year, two (2) periodic surveillance's have been performed, the most recent inspections completed in August 2022. A periodic surveillance consists of an EPA/AHERA Licensed Asbestos Building Inspector visually inspecting all areas that contain Asbestos Building Materials. This inspection, in no way, poses any harm to the occupants of the building.

During the past 3 years, Asbestos Abatement projects have been performed throughout the school district. All Abatement projects have been performed in strict compliance with all Federal, State, and Local Regulations, and Final Reports are on file at the main office of each school and at the Board Office.

The Management Plan with the inspection reports is located in each Main Office of each school; master copies are located at the Board of Education Office, Traphagen School. These reports are available for review upon request.

NOTICE TO ALL SHORT TERM WORKERS

It has been determined that this facility contains Asbestos Containing Building Materials (ACBM). According to Federal Law (40 CFR 763.84) we must:

"Ensure that short-term workers (e.g. telephone repair workers, utility workers, or exterminators) who may come in contact with asbestos in a school are provided with information regarding the locations of ACBM and suspect ACBM."

The AHERA Legislation also mandates that all "Relevant Federal and State Regulations concerning asbestos", be enforced {40 CFR 763.84 (g) (2) (v)}. According to NJAC 12:100-12-13 (a), (b), & (c), any workers which have *Direct Exposure* to asbestos must be trained by a state approved agency. *Direct Exposure* means potential exposure to asbestos fibers to employees who perform large, small, and minor abatement work, initial cleaning in an area containing damaged friable asbestos, and routine maintenance which may disturb asbestos or cause contact with damaged asbestos containing materials. *Direct Exposure* also means potential exposure to asbestos fibers to employees who contact, work with, disturb, repack, and handle asbestos or asbestos containing materials (NJAC 12:100-12.2). If the performance of your duties requires your direct exposure to ACBM you will be asked to produce documentation that you have had the required training under NJAC 12:100-12.13(c) before handling any asbestos containing materials.

The AHERA Legislation requires that all public and non-profit schools, Kindergarten through Twelfth grade make available to the public the results of the asbestos inspection and management plan. A copy of this facility's plan is available in this office and at the district office during normal business hours.
