### COMMENTS FROM TRUSTEES – ANY SUBJECT

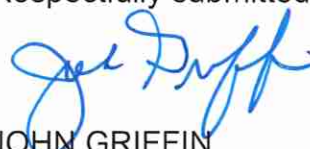
Trustee Mangler asked about Class III officers for next school year.
